

During the last 20 years of my 39 year career at the Iowa Department of Transportation I managed the Office of Project Planning. We were responsible for preliminary development of all new highway projects. We looked at alternate locations, conducted the necessary environmental studies, prepared the required environmental impact statements and conducted public hearings to share our findings with those affected by the projects. I was responsible for an annual budget of approximately \$7 million. In addition, I managed the \$11 million per year RISE program which assisted cities and counties in attracting new industrial type jobs, and a \$10 million per year Transportation Enhancement program. The latter program focused on bicycle/pedestrian trails, historic preservation, and roadside plantings. These experiences have made me fully cognizant of the need for meaningful citizen involvement in making sound public decisions. It also made me aware of the need for careful examinat ion of expenditures of public funds. In each of those 20 years I was under budget every year. I was a member of the following organizations:

I love books and am an avid reader, and since my retirement in 2000 from the DOT have been a frequent visitor to the city library. I came to Ames to attend Iowa State, and except for a two year tour of duty (1962-1964) in the Army, my wife and I have lived here since graduation. We have endowed a library in the recently completed Beloit Residential Center building and have purchased books for the children. We have also volunteered in other community activities as our children were growing up, but this is one area, the Library Board which has really attracted my attention and interest. I am currently a member of the Beloit Advisory Board, Golden K Kiwanis and the Executive Board of the Ames American Legion.
