**SUBJECT:** Appointment to Fill Vacancies on Parks and Recreation Commission

There currently exist two vacancies on the Parks and Recreation Commission. Greg Vitale has submitted his resignation from the Board due to out-of-town schedule conflicts. Laura Bosworth, appointed to the one-year term, has had difficulties attending the Board meetings and is no longer serving in this capacity.

Greg's term of office does not expire until April 1, 2013, and an appointment needs to be made to fill this vacancy. An appointment to serve out the remaining five months of the one-year term needs to be made as well.

Therefore, I request that the City Council approve appointments to the Parks and Recreation Commission as follows: Victoria Feilmeyer to fill the term of office expiring April 1, 2013, and Jason Schaben to fill the term of office expiring April 1, 2011. Both Victoria and Jason would be eligible for reappointment.
