## **ORDINANCE NO.**

AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF AMES, IOWA, AS PROVIDED FOR IN SECTION 29.301 OF THE MUNICIPAL CODE OF THE CITY OF AMES, IOWA, BY CHANGING THE BOUNDARIES OF THE DISTRICTS ESTABLISHED AND SHOWN ON SAID MAP AS PROVIDED IN SECTION 29.1507 OF THE MUNICIPAL CODE OF THE CITY OF AMES, IOWA; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH AND ESTABLISHING AN EFFECTIVE DATE

**BE IT HEREBY ORDAINED** by the City Council of the City of Ames, Iowa;

<u>Section 1</u>: The Official Zoning Map of the City of Ames, Iowa, as provided for in Section 29.301 of the *Municipal Code* of the City of Ames, Iowa, is amended by changing the boundaries of the districts established and shown on said Map in the manner authorized by Section 29.1507 of the *Municipal Code* of the City of Ames, Iowa, as follows: That the real estate, generally located at 4098 E.13<sup>th</sup> Street, is rezoned from Planned Industrial (PI) with the Northeast Gateway Overlay (O-GNE) to General Industrial (GI) with a Master Plan and remove the Northeast Gateway Overlay (O-GNE).

## **Real Estate Description:**

Survey Description-Area to be Rezoned:

Parcel A in the Northwest Quarter, as shown on the Plat of Survey filed at Inst.
