## SUBJECT: RESOLUTION AUTHORIZING THE MAYOR TO SIGN "CERTIFICATION OF LOCAL GOVERNMENT APPROVAL" ON BEHALF OF LOCAL NONPROFIT ORGANIZATIONS APPLYING FOR EMERGENCY SHELTER GRANT (ESG) FUNDS.

## BACKGROUND:

In order for three local non-profit agencies, Assault Care Center Extending Shelter and Support (ACCESS), The Bridge Home (TBH), and Youth and Shelter Services (YSS), to apply for funding under the Federal Emergency Shelter Grant (ESG) Program, they are required to submit a "Certification of Local Government Approval" from the City of Ames. If they are awarded funding through this program, the certification allows these non-profit agencies to receive these federal funds directly through the State of lowa's lowa Finance Authority (IFA).

Additionally, these certifications confirm that local governments are electing to have IFA administer these grant funds on behalf of the non-profit organizations, rather than the City. For the calendar year beginning January 1, 2024.

The attached "Certifications of Local Government Approval" for all three agencies must be submitted with their applications to IFA on or before July 25, 2023.

## ALTERNATIVES:

1. The City Council can authorize the Mayor to sign the Certifications of Local Government Approval on behalf of ACCESS, TBH, and YSS.
2. The City Council can choose not to authorize the Mayor to sign the Certifications of Local Government Approval on behalf of ACCESS, TBH, \& YSS.

## CITY MANAGER'S RECOMMENDED ACTION:

Receiving ESG grant funds administered through the lowa Finance Authority is very important in helping these agencies provide much-needed services and financial support for homeless individuals and families fleeing domestic violence, facing and experiencing homelessness, and for homeless youth in our community. Therefore, it is the recommendation of the City Manager that the City Council adopt Alternative \#1.
