March

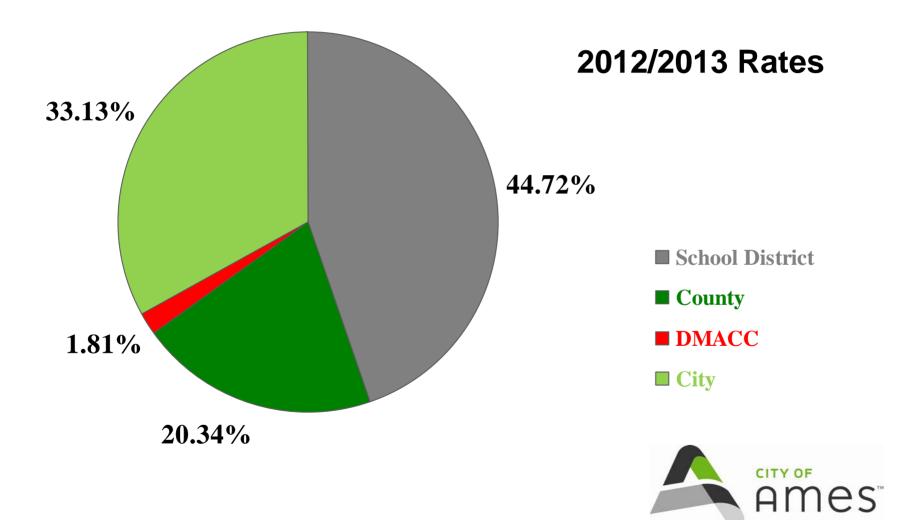

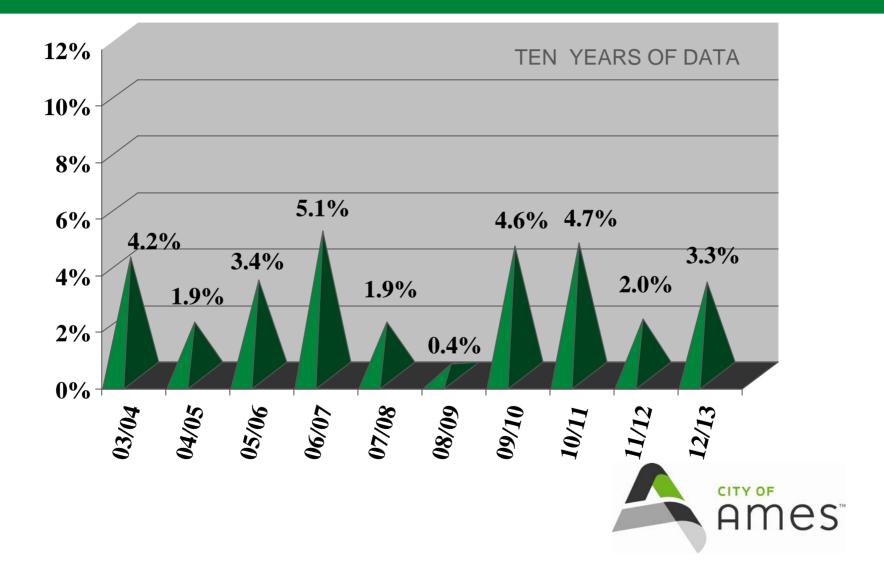

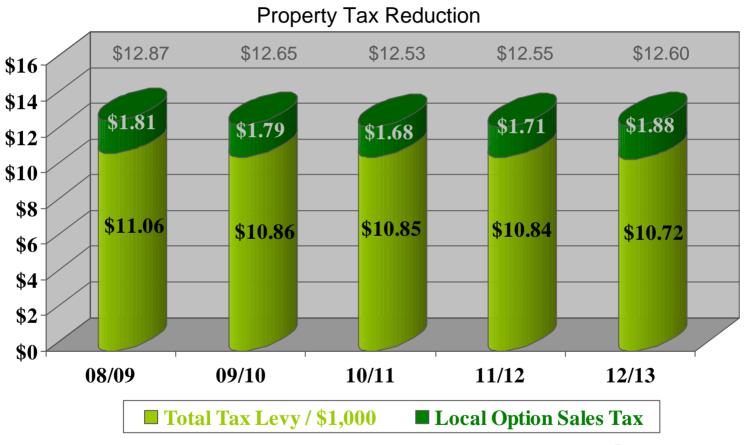
PROPERTY TAXES PAID



VALUATION PERCENTAGE INCREASE

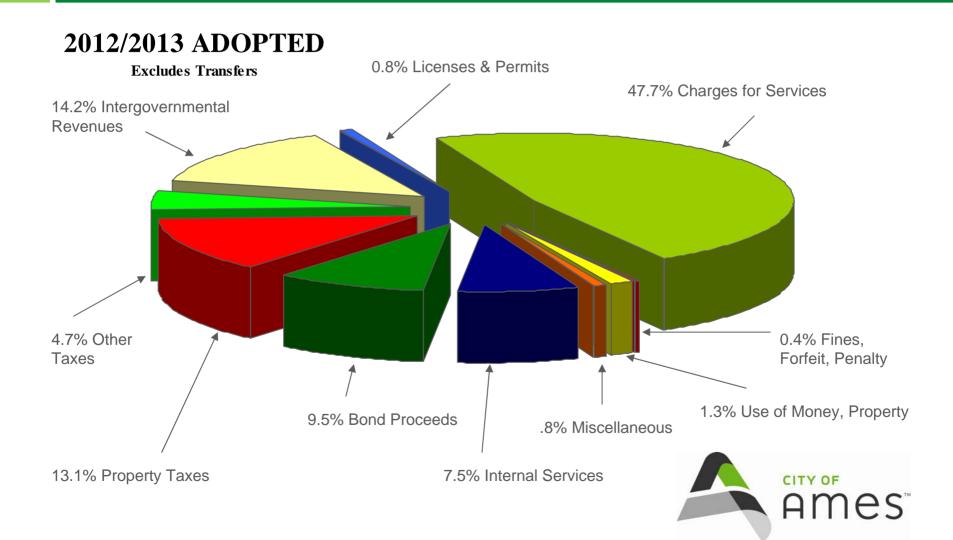


LOCAL OPTION SALES TAX

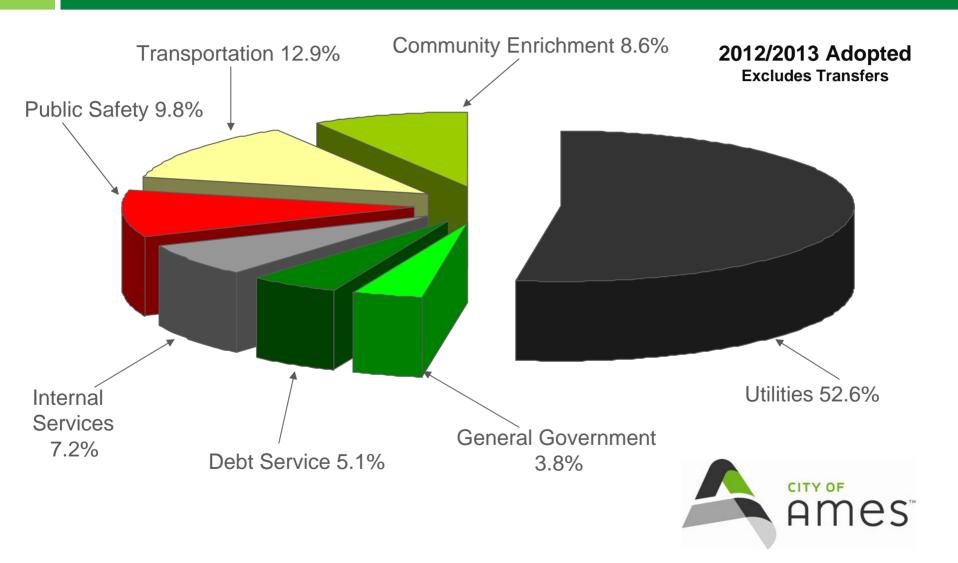
