SUBJECT: SOUTHEAST ENTRYWAY PROJECT COMPLETION (PHASE 1)

BACKGROUND:

The City Council previously approved a Design Concept for Ames Southeast Entryway and directed staff to take some steps toward implementing the first phase of the project. The first phase included prairie savanna plants and intersection landscaping in the U.S. 30/South Dayton Avenue/Southeast 16th Street area. The City then received a \$98,100 grant from the Iowa Department of Transportation/Department of Natural Resources to reimburse the City up to this amount for portions of this project.

The completion date for the supply and installation of trees, shrubs, native grasses, and wildflowers (including maintenance and warranty for the plantings) was originally set for spring 2005. However, challenges in coordinating the in-kind contributions delayed the project. On June 26, 2007, City Council approved Change Order 5 in the amount of \$23,229, which was necessary to alleviate erosion control issues.

Construction has now been completed in the amount of \$78,315.03. This work is part of a larger project that will eventually include light columns and other improvements under Phase 2.

In working with the IDOT, the work items under change order #6 were determined to be necessary in order to meet the specifications for flume size as required by the IDOT.

The work under this contract has now been completed and the certification of completion by the Director of Planning & Housing is attached. However, as outlined below the total of the project exceeds the amount available through the IDOT Grant and the City Share in the amount \$2,581.00

It is the recommendation of the City Manager that the City Council adopt Alternative No. 1, thereby accepting the Entryway Project (Phase 1) as completed by Atron, Inc. of Ames, IA, in the amount of \$78,315.03 and spending the shortfall balance out of the donations from the area business line item.
