SUBJECT: MAIN STREET CULTURAL DISTRICT REQUESTS FOR JANUARY SIDEWALK SALES

BACKGROUND:

The Main Street Cultural District (MSCD) is planning to host its annual sidewalk sales from January 28 through 30, 2010, and makes the following requests of the City Council:

- a. Waiver of parking meter fees and enforcement in the Central Business District (CBD) from Thursday, January 28, through Saturday, January 30
- Blanket Temporary Obstruction Permit for CBD sidewalks from 8:00 a.m. to 6:00 p.m., January 28 30
- c. Blanket Vending Permit for entire CBD for January 28 30
- d. Waiver of fee for Blanket Vending Permit

The waiver of parking meter fees and enforcement will lead to a loss of approximately \$2,700 to the City's Parking Fund.

ALTERNATIVES:

- 1. The City Council may approve the January Sidewalk Sales requests as submitted by the Main Street Cultural District
- 2. The City Council may deny these requests.

MANAGER'S RECOMMENDED ACTION:

The MSCD Sidewalk Sales is a successful event held twice a year. Since these events bring shoppers to the MSCD, these requests further the City Council's goals to continue to provide support for the downtown commercial area.

Therefore, it is the recommendation of the City Manager that the City Council adopt Alternative No. 1, thereby approving the January Sidewalk Sales requests as submitted by the MSCD.
