The City Council agenda includes a 12-month liquor license renewal application for Mickey's Irish Pub. The most recent license application was renewed for 6 months with the expectation that the establishment would improve management practices. We believe the bar has successfully addressed the issues raised by the police department during the previous renewal process. Mickey's was cited for an overcrowding violation on October 31, 2009. Since that violation, the bar has taken corrective staffing action to address access through a rear door.

Based on the positive changes that have occurred, the police department recommends approval of their 12-month license application.
