Staff Report

AMES CITY AUDITORIUM FEES

February 3, 2020

BACKGROUND:

At the Town Hall Budget meeting on October 29, 2019, members of local arts groups expressed concern regarding funding for the arts, specifically, COTA funding and Ames City Auditorium (ACA) fees. One group, Story Theater Company, expressed concern regarding the fee increases the group will be encountering in FY 20/21. At its December 17, 2019 meeting, Council directed staff to provide a history of ACA fees and provide options to make the Auditorium more affordable for non-profits.

Ames City Auditorium Budget:

The chart presented below shows a steady increase in expenses and revenues while the subsidy is staying relatively flat for FY 17/18 through FY 20/21. Please note that in FY 15/16 the Auditorium Manager position was half-time and vacant and in FY 16/17, the Manager position was increased to full-time with 80% of staff time being allocated to the ACA. In addition, Hope Lutheran Church started renting space in FY 17/18 with estimated rental fees to be \$37,053 in FY 2020/21.

Ames City Auditorium User Groups:

A complete listing of user groups since 2016 is included in Attachment A. As you will see, the users have been placed into several categories which are shown below:

This breakdown offers the City Council an overview of the different types of nonprofit groups utilizing ACA. Also, it should be noted that seven of the groups in the Community Arts category receive COTA funding.

Ames City Auditorium Rental Rates:

The Parks and Recreation Commission approves fees and charges each year and these are shown in Attachment B (FY 19/20), C (FY 20/21) & D (FY21/22). Several years ago, the Commission began approving Auditorium fees two years in advance. This was in response to feedback from COTA recipients that Auditorium fees were approved after COTA funding requests were due and that made it difficult to complete the COTA request accurately.

The current Auditorium fee schedule includes rates based on whether a group is a nonprofit organization or a for-profit organization. Groups can choose between an hourly rate and a day rate and the group's final fee is based on either that rate or 10% of the gross ticket/admission receipts, whichever is higher. The rental rates have increased 3% each year since FY 18/19. These rates include one staff member on site during the rental period. Groups are charged extra if additional staff is requested or additional spaces are rented (e.g. gym, lunchroom, etc.).

Prior to FY 18/19, there was a third rental rate category which was for Ames Community Arts Council (ACAC) affiliates. Groups (nonprofit and for profit) could join ACAC for a fee and then receive discounted rates of approximately 25% for Auditorium rental fees. For ACAC members, there were three rates that could be used for billing (FY 17/18 fees are shown below).

- 1. <u>Per Hour Rental Rate</u> This fee was \$75 per hour for up to eight hours per day or \$1.00 per seat used, whichever was higher. Each additional hour over eight hours was billed at \$35 per hour.
- 2. <u>Day Rate</u> This was \$700 per day and the user had the Auditorium for the entire day.

3. Extended Use Rate – This allowed ACAC members the ability to use the Auditorium for multiple days (minimum of five, maximum of fourteen) within a fourteen day period at a rate of \$450 per extended use or \$1.45 per seat, whichever is higher, plus a \$185 non-refundable deposit. The user could utilize the Auditorium for up to four hours per day with this rate. Each additional hour over four hours was billed at \$40 per hour. It should be noted that only two groups were using the extended use rate, Story Theater Company and Co'Motion Dance.

Please also note that prior to FY 18/19, fees were listed with a per hour charge and per seat charge. ACAC and non-profit groups either paid a rental fee or a per seat charge, whichever was higher. For Profit Groups paid a rental fee and a per seat charge.

Prior to making any rental rate changes, staff reached out to other venues and professional peers to gather information as to what was being done in other locations. Based on this information and feedback from user groups, changes were made and are reflected in the current fee schedules. Non-ACAC groups experienced a fee increase in FY 18/19 when the changes took effect, while ACAC groups saw an increase in FY 19/20. Story Theater Company and Co'Motion Dance were grandfathered in and were still able to use the Extended Use Rate through FY 19/20. This provided them time to prepare for the elimination of the Extended Use Rate, as well as, the fee increase.

There are three other changes made in FY 18/19 to note. The first is the addition of a Facility Fee that is now assessed per ticket. The second is there is now prime time and non-prime time hours for nonprofit groups. This does provide a discounted rate for some groups based on when they are renting the Auditorium. The third is there is now a frequent user discount of five percent if a group rents more than 100 hours per year. Story Theater Company will qualify for this discount. Additionally, the balcony and the sound shell were included, whereas before there was a separate fee for these two items.

OPTIONS:

Option 1. Provide An Incentive To Story Theater and Co'Motion Dance By Retaining The Extended Use Rate With The \$2.25 Per Seat Charge

As evidenced by the chart shown below, because Story Theater and Co'Motion Dance were grandfathered and not subject to the shift as other groups were, they will be most impacted in FY 2020/21 from a switch from the Extended Use Rate to a per hour rate.

It should be noted that the FY 18/19 numbers reflected in this chart are based on actual hours and seats used, while the FY 19/20 and FY 20/21 totals are estimates based on FY 18/19 actuals.

Under this option, the City Council would decide to continue to provide this incentive for only Story Theater Company and Co'Motion Dance in FY 2020/21 by retaining the current Extended Use Rate and the \$2.25 per seat fee. This option would save the Story Theatre Company \$4,959 (\$15,393-\$10,434) and Co'Motion Dance \$1,799 (\$3,009-\$1,210).

In order to accomplish this Option 1, the City Council would have to increase the property tax rate to generate an additional \$6,758 above the current City Manager's Recommended Budget or decrease General Fund expenditures by this same amount.

Option 2. Provide A Percentage Discount To All Community Arts/ISU Groups

This option recommends the creation of a City Auditorium Community Arts Partner Program. City staff would develop a list of criteria to be approved by the City Council for the program. The granting of the pre-approved percentage of subsidy to anyone of the Community Arts/ISU groups listed on Attachment A would be dependent upon which groups meet the prescribed eligibility criteria.

The value of each discount based on prior usage and possible percentages are estimated above. Therefore, in order to accomplish Option 2, the City Council would have to increase the property tax rate to generate an amount equal to the total amount of the discount selected above or decrease General Fund expenditures by this same amount.

Option 3. Provide A Percentage Discount To All Non-Profits

This option does not distinguish among non-profit groups. All of these groups would be eligible for the same pre-approved across-the-board discount. Here again, the amount of subsidy granted is dependent on the percentage of discount determined by the City Council. The table highlighting the estimated cost of the subsidy is provided below.

Under this option, the City Council would have to increase the property tax rate to generate an amount equal to the total amount of the discount selected above or decrease General Fund expenditures by this same amount.

STAFF COMMENTS:

Since this issue was raised in regards to the community arts groups' use of the City Auditorium, would it seem preferable for the City Council to focus on Options 1 and 2. To date, the Parks and Recreation Staff has indicated that only the Story Theater Company has expressed concern about the proposed fee increases introduced last year. Therefore, the Council could consider as a first step, moving ahead with Option 1 for FY 2020/21.
