<u>SUBJECT</u>: NON-ASBESTOS INSULATION AND RELATED SERVICES AND

SUPPLY CONTRACT FOR POWER PLANT - CONTRACT

RENEWAL

BACKGROUND:

This contract involves the removal, repair, and reinstallation of non-asbestos insulation of all types used at the City's Power Plant.

On July 23, 2019, City Council awarded a contract to HTH Companies, Inc., Union, Missouri, for the Non-Asbestos Insulation and Related Services and Supplies Contract Power Plant. This contract included the option for the City to renew in one-year increments for up to four additional years. The period from July 1, 2021 through June 30, 2022, is the second of the four-renewal periods subject to Council approval of funding for non-asbestos insulation services.

The contract's rate provision increase is 2% for both Labor and Travel & Subsistence. The FY 2021/22 rates are shown on Attachment 1. The benefits of having a contract for these services in place include the following:

- 1) Consistency of work and quality from a single contractor.
- 2) Reduction in the City's exposure to market forces regarding prices and availability for labor, travel, and supplies in preparation for a scheduled outage.
- 3) Rapid contractor mobilization to start emergency repairs, thus reducing generation downtime.
- 4) Saved City staff time obtaining quotes, evaluating bids and preparing specifications and other procurement documentation.

The approved FY 2021/22 Power Plant operating budget includes \$150,000 for this contract. Invoices will be based on contract rates for time and materials for services actually received.

<u>ALTERNATIVES</u>:

- a. Approve contract renewal with HTH Companies, Inc., Union, Missouri, for the Non-Asbestos Insulation and Related Services and Supplies Contract for the one-year period from July 1, 2021, through June 30, 2022.
 - b. Approve a performance bond in the amount of \$150,000.
- 2. Do not renew the agreement and instruct staff to seek new competitive bids.

CITY MANAGER'S RECOMMENDED ACTION:

This contract is needed to carry out emergency and routine non-asbestos insulation services at the Power Plant. The contract will establish rates for service and provide for guaranteed availability, thereby setting in place known rates for service.

Therefore, it is the recommendation of the City Manager that the City Council adopt Alternative No. 1 as stated above.
